Exhibition Rules and Guidelines

The following are to benefit all participants, and will be enforced throughout the festival:

All booths must be ready to open by 6:00 pm, and remain open until 10 pm Saturday evening.

Deviation from items listed on your application could result in the closing of your booth, with no refund of booth fee.

Electricity is available for an additional charge of \$25.00 per outlet. Each outlet is 20 amp/120 voltage.

If you require more amperage you will need to purchase more than 1 outlet.

There will be no rain date. A registration is a commitment to show. NO REFUNDS will be made NO EXCEPTIONS.

Each exhibitor must provide his or her own display. This is an OUTDOOR event. Come prepared for any weather. Freestanding canopies are recommended. Any stakes, weights or other "tie-down" equipment must remain inside booth dimensions.

All display items, shelving, or any merchandise must remain within the assigned space. This will be strictly enforced. Be considerate of your neighbors.

Tables MUST be draped to the ground on ALL FOUR SIDES.

Single booth dimensions are 10' x 10'... Double booths are 10'x20'. All spaces are on pavement and some spots may have uneven terrain within the assigned space, come prepared.

Your display should be attractive and operated in good taste. No participant may sell illegal or immoral items. Cleveland Better Home Town reserves the right to disallow selling of disruptive, dangerous, damaging, etc. items. Anyone in violation of these restrictions will be escorted off the premises immediately. THIS IS A FAMILY ORIENTED EVENT.

Each exhibitor is responsible for collecting and reporting appropriate sales tax.

SET-UP BEGINS: Saturday, July 26, 4:30pm (Vehicles MUST be moved to designated parking by 5:00 PM) **BREAKDOWN:** Saturday, July 26 after 10 p.m. only (No early breakdown or departure). Must be off the Square by 11:00 p.m. Bring trash bags to clean up your area prior to departure.
