Exhibition Rules and Guidelines

REGISTRATION STEPS:

- Fill out application completely
- Fill our Food Service Permit
- Make a copy of the completed permit

Health Department Requirements: A Temporary Food Service permit is required from each vendor. The permit can be downloaded from our website or sent to you by contacting Cleveland Better Home Town.

General Rules: Each exhibitor must provide his or her own display. This is an OUTDOOR event. Come prepared for all weather conditions. Freestanding canopies or trailers are recommended. Any weights or other “tie-down” equipment must remain inside booth dimensions. Stakes are not allowed. Be considerate of your neighbors. Tables MUST be draped to the ground on ALL FOUR SIDES. If you require additional space, you must get prior approval. All spaces are on pavement or gravel and some spots may have uneven terrain within the assigned space, come prepared. There will be no rain date. A registration is a commitment to show.

Your display should be attractive and in good taste. We would like each booth to have a Fall Leaf theme. No participant may sell illegal or immoral items. Cleveland Better Home Town reserves the right to disallow selling of disruptive, dangerous, damaging, etc. items. Anyone in violation of these restrictions will be escorted off the premises immediately. **THIS IS A FAMILY ORIENTED EVENT.** Deviation from items listed on your application could result in the closing of your booth. Each exhibitor is responsible for collecting and reporting appropriate sales tax.

SET-UP BEGINS: Saturday, December 4, 2010 after 10:00am (set-up by 12:00pm)

BREAKDOWN: Saturday, December 4 after 8:00 p.m. (No early breakdown or departure). Vendors must be off grounds by 10:00 p.m. Bring trash bags to clean up your area prior to departure.

YOU WILL NOT BE ALLOWED TO HAVE A VEHICLE AT YOUR BOOTH, NO EXCEPTIONS!
